Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2013

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$875,968,501 for the month of November 2013. This amounts to an 11.91% <u>increase</u> compared to November 2012, when licensees reported a gaming win of \$782,770,511. For the fiscal year (July 1, 2013 through November 30, 2013), gaming win has increased 3.32%.

Percentage Fee Collections for the Month of December 2013

The State collected \$49,980,270 in percentage fees during the month of December 2013*, based upon the taxable revenues generated in November 2013. This represents a 9.25% (or \$4,232,427) <u>increase</u> compared to the prior year's December, when percentage fee collections were \$45,747,843.
