Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2014

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$970,265,587 for the month of May 2014. This amounts to an 8.11% <u>increase</u> compared to May 2013, when licensees reported a gaming win of \$897,438,790. For the fiscal year (July 1, 2013 through May 31, 2014), gaming win has increased 2.04%.

Percentage Fee Collections for the Month of June 2014

The State collected \$56,215,980 in percentage fees during the month of June 2014*, based upon the taxable revenues generated in May 2014. This represents a 2.43% (or \$1,400,497) decrease compared to the prior year's June, when percentage fee collections were \$57,616,477.
