# **Nevada Gaming Revenues and Collections**

# Win Revenue Summary – October 2014

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$913,643,061 for the month of October 2014. This amounts to a 4.26% <u>decrease</u> compared to October 2013, when licensees reported a gaming win of \$954,319,750. For the fiscal year (July 1, 2014 through October 31, 2014), gaming win has decreased 3.29%.

## Percentage Fee Collections for the Month of November 2014

The State collected \$66,803,398 in percentage fees during the month of November 2014\*, based upon the taxable revenues generated in October 2014. This represents a 9.46% (or \$5,774,394) increase compared to the prior year's November, when percentage fee collections were \$61,029,004.
