Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$897,232,001 for the month of May 2013. This amounts to a 1.37% increase compared to May 2012, when licensees reported a gaming win of \$885,086,491. For the fiscal year (July 1, 2012 through May 31, 2013), gaming win has increased 2.36%.

PRESS RELEASE

Percentage Fee Collections for the Month of June 2013

The State collected \$57,453,708 in percentage fees during the month of June 2013, based upon the taxable revenues generated in May 2013. This represents a 10.85% (or \$5,624,035) increase compared to the prior year’s June, when percentage fee collections were \$51,829,673.
