Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$955,281,446 for the month of August 2013. This amounts to an 11.17% increase compared to August 2012, when licensees reported a gaming win of \$859,261,683. For the fiscal year (July 1, 2013 through August 31, 2013), gaming win has increased 0.85%.

Percentage Fee Collections for the Month of September 2013

The State collected \$51,356,197 in percentage fees during the month of September 2013\*, based upon the taxable revenues generated in August 2013. This represents a 3.46% (or \$1,715,322) increase compared to the prior year’s August, when percentage fee collections were \$49,640,875.
