Nevada Gaming Revenues and Collections

Win Revenue Summary – October 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$954,331,806 for the month of October 2013. This amounts to a 2.58% decrease compared to October 2012, when licensees reported a gaming win of \$979,596,839. For the fiscal year (July 1, 2013 through October 31, 2013), gaming win has increased 1.52%.

Percentage Fee Collections for the Month of November 2013

The State collected \$60,963,944 in percentage fees during the month of November 2013*, based upon the taxable revenues generated in October 2013. This represents an 11.89% (or \$6,477,406) increase compared to the prior year's October, when percentage fee collections were \$54,486,538.
