Nevada Gaming Revenues and Collections

Win Revenue Summary – March 2015

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$951,245,276 for the month of March 2015. This amounts to a 3.15% decrease compared to March 2014, when licensees reported a gaming win of \$982,175,517. For the fiscal year (July 1, 2014 through March 31, 2015), gaming win has decreased 2.12%.

Percentage Fee Collections for the Month of April 2015

The State collected \$79,378,209 in percentage fees during the month of April 2015*, based upon the taxable revenues generated in March 2015. This represents a 5.64% (or \$4,745,662) decrease compared to the prior year's April, when percentage fee collections were \$84,123,871.
